

WELCOME

Dear Student,

Welcome to the Children In Care Nursing Team. Your named student Supervisor / Assessor for this placement will be:

Your named supervisor / assessor will be your main source of support and will be responsible for undertaking your learning contract, mid and endpoint interviews. You will also have the opportunity to work with other members of the team who may also undertake your assessments.

Our service runs from 08:30until 17:30, Monday to Friday. Your shift times can be negotiated with your assessor, taking into account your learning needs, maximising time with your supervisors, personal circumstances, travel arrangements etc.

There are several areas (spokes) in which you can spend time; you can arrange these spokes yourself. Contact details are at the end of this booklet.

We hope you enjoy your placement here. If you have any problems, questions or concerns please discuss them with one of your mentors as early as possible so they can be addressed.

Usual uniform should consist of trousers and a white student tunic top. You may also be able/be requested to wear smart casual clothing, as per Trust Uniform Policy. Please ensure you wear your name badge at al times.

Our service operates weekdays, across East Sussex. The team are based at Centenary House in Eastbourne. We also at times work from Park View in Egerton Park, Bexhill.

You will get an opportunity to work with different Nurses in the team as well as other professionals. We work alongside Paediatricians, CAMHS and Looked After Children CAMHS, Safeguarding Children Team, School Health and other professionals. You will observe multi-agency working and gain an understanding of how multi-agencies work together to promote the health needs of Children In Care.

You will be encouraged to engage with carers and children, as appropriate, and will observe trauma informed care in practice.

Working with Children In Care is rewarding but sometimes it can be upsetting. If you ever need a pause or want to talk about something you've experienced during your placement, please let your supervisor or one of the team know. We are here to support you.

We look forward to supporting you in your placement and hope you find it interesting and a valuable experience.

Who We Are

We are a team of Specialist Nurses and administrators; we work with Children In Care aged 0-18yrs and assess, plan and co-ordinate their health needs.

We carry out statutory review health assessments with children and their Carers in Foster Homes, Children's Residential Homes, Assisted Living accommodation and Clinic settings. Sometimes assessments are carried out virtually or over the phone depending on what the child or young person prefers.

When young people turn 18yrs old, they leave care and are discharged from our service. Prior to leaving, they are offered a Leaving Care Health Summary and an appointment to advise them on where to access healthcare / support as an adult.

We sometimes visit Children In Care and Carers to offer advice and support if they have a health concern

Glossary of Terms

CIC - Children In Care

LAC – Looked After Children; this is a term we no longer use as CIC told us they don't like it

UASC – Unaccompanied Asylum Seeking Child

IHA - Initial Health Assessment

RHA - Review Health Assessment

LCS – Leaving Care Summary

CO – Care Order

ICO - interim Care Order

CAMHS – Child Adolescent Mental Health Service

LACMHS - Looked After Children Mental Health Service

FISS – Family Intensive Support Service

LDFISS – Learning Disability Family Intensive Support Service

SPOA – Single Point Of Access (where children's services /CAMHS referrals are sent)

HV – Health Visiting

MDT - Multi-Disciplinary Team

Paperwork

In our team we use the Coram BAAF forms to complete the Statutory Review Health Assessments for Children In Care. These are completed every six months for children under 5yrs of age or every 12 months for children 5-18yrs.

Paediatricians use the Coram BAAF Initial Health Assessment forms to complete a statutory health assessment within 28 days of a child or young person coming into care. Here is a video we send to children / young people new to care to explain about the IHA process:


